1. Confirmation of Booking

A non-refundable deposit of £10.00 per head is required to secure any booking. Confirmation of all bookings will be sent in writing, following receipt of a completed booking form and deposit cheque.

Please make cheques payable to WISEVILLE & CO LTD.

2. Cancellations

2.1 By the Organiser

2.1.1 Between one and three months prior to the confirmed date – 50% of the estimated value of the booking will be charged and invoiced.

2.1.2 Between seven days and one month prior to the confirmed date – 75% of the estimated value of the booking will be charged and invoiced.

2.1.3 Less than seven days prior to the confirmed date – 100% of the estimated value of the booking will be charged and invoiced.

2.2 By Bletchingley Golf Club

The Club reserves the right to cancel or amend any reservations. In this event the Club will refund any deposit made in respect of golf, but will have no further liability to the Organiser.

2.3 Weather

No reductions or refunds shall apply if the weather affects a confirmed booking in any way whatsoever.

3. Confirmation of Numbers

The Organiser is required to confirm to the Club precise numbers at least 48 hours prior to the date of the confirmed booking.

3.1 If the Organiser wishes to increase the numbers then, subject to availability, such additional numbers will be accommodated and charged accordingly.

3.2 If the Organiser wishes to decrease the numbers between 48 hours and seven days before the confirmed booking, the decrease in numbers will be charged at 75% of the estimated value of the numbers cancelled.

3.3 If a decrease in numbers is received less than 48 hours before the confirmed date the decrease in numbers will be charged at 100% of the estimated value of the numbers cancelled.

4. Bar Account

Bar accounts can be arranged in advance with the Catering Manager. A charge of 10% for staff gratuities will be added.

5. Tee Times/Meal Times

Reserved tee times and meal times are pre-arranged and therefore it is essential that these are strictly adhered to.

6. Damage

The Organiser, in accepting these Terms and Conditions assumes responsibility for any and all damage caused by him or any member of his party, whether in the Clubhouse or on the golf course.
